- M-1** Motion was made by Mr. Borcik, Seconded by Ms. Mariner, to approve the renewal of Principal's Life, Accidental Death and Dismemberment, Long Term Disability and Short Term Disability for the period of August 1, 2017 through July 31st, 2018 in the amount of \$7,663.20. Upon roll call vote, Rev. Turner, Rev. Benton, Ms. Mariner, Ms. Burwell, Mr. Borcik, and Mr. Cunningham voted yes. Motion carried 6 – 0.
- M-2** Motion was made by Ms. Burwell, Seconded by Ms. Mariner, to approve the renewal of SWIF/Workers Compensation for the Borough of Homestead for the period of August 1, 2017 through July 31<sup>st</sup>, 2018 in the amount of \$210,944. Upon roll call vote, Rev. Turner, Rev. Benton, Ms. Mariner, Ms. Burwell, Mr. Borcik, and Mr. Cunningham voted yes. Motion carried 6 – 0.

- M-4** Motion was made by Ms. Burwell, Seconded by Rev. Turner, to hire Adam Greenebaum as a full-time police officer at a rate of \$17.03 per hour effective August 7th, 2017 per the collective bargaining agreement. Upon roll call vote, Rev. Turner, Rev. Benton, Ms. Mariner, Ms. Burwell, Mr. Borcik, and Mr. Cunningham voted yes. Motion carried 6 – 0.

Turner, to hire Manuel Pihakis as a full-time police officer at a rate of \$17.03 per hour effective August 7th, 2017 per the collective bargaining agreement. Upon roll call vote, Rev. Turner, Rev.
